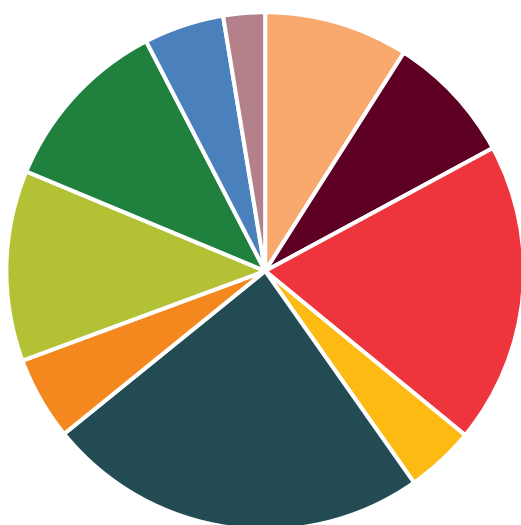

CURRENT ASSET CLASS BREAKDOWN

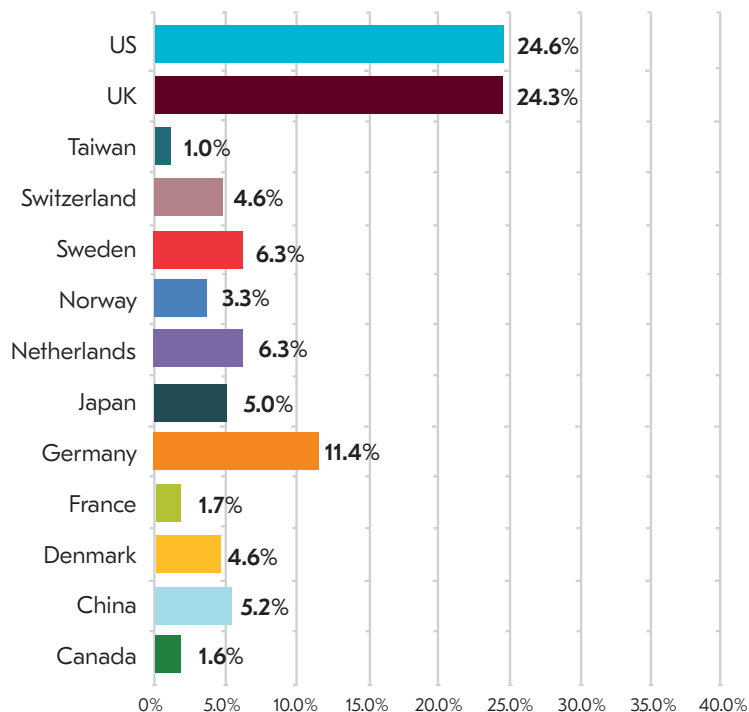
